



TEKKARISAUNA RULES

The costs of non-compliance with these rules shall be borne by the renter. If the renter violates the principles mentioned in these rules, the reservation can be cancelled and/or the party that booked the reservation will be banned from renting the sauna for a period decided by the board of the Union.

The sauna renter undertakes to comply with the following rules:

1. The user takes care of turning the sauna heater (Fin: kiuas) on and off during the sauna evening. The heater control panel is in the dressing room. The air conditioning does not need to be adjusted but adjusts automatically based on the humidity and the amount of carbon dioxide in the air.
2. Normal cleanliness and respectfulness must be observed in the use of the premises. Windows and doors should be kept closed. Excessive noise should be avoided, especially outdoors.
3. The sauna must be cleaned carefully according to the instructions before the end of the rental period. Vomit, cigarette butts and other debris in the sauna, the yard and its immediate vicinity should be cleaned out. **Cleanliness is checked at the end of the rental period and extra costs are added to the rent from deviations.** Cleaning equipment can be found in the cleaning cupboard next to the toilets. Biowaste, cardboard and mixed waste are sorted into containers next to the outdoor shed.
4. The renter is responsible for any damage that users may cause to the sauna, its equipment, furniture, yard and nearby areas. The sauna renter is obliged to immediately report any damage to the Union's Sauna Minister. It is forbidden to attach notes, garbage bags and other things to wall surfaces.
5. The hot tub is reserved separately when renting for an additional fee. The hot tub must not be heated empty or emptied while there is still a fire in the stove. When bathing, care must also be taken to add water to replace the lost bath water. Ash must be removed from the stove during heating to prevent the grate from melting. The firewood is in the outdoor shed (entrance from the canopy side).
6. The renter is responsible for closing the sauna windows and **locking the exterior doors** after the end of use. The tenant takes care of turning off and on the burglar alarm. Unnecessary alarms will be billed to the tenant.
7. The reservation starts at 12:00 on the day of booking and ends at 9:00 the next day, unless otherwise agreed in the rental agreement. Tampereen Teekkarit ry is entitled to charge for the exceeded rental period. At the end of the rental period, the bottles, cans and foodstuffs left in the sauna will be transferred to the ownership of Tampereen Teekkarit ry. Lost property is stored for one month and can be inquired from the Sauna Minister saunamestari@tampereenteekkarit.fi.
8. It is recommended to park cars in the parking lot. If parking overnight and for the next day, cars are recommended to be parked on the curb.
9. After use, the dishes must be washed and put in place. The dishwasher must not be left on unattended.
10. Users are obliged to follow the instructions given by the Sauna Minister. The Sauna Minister has the right to interrupt the sauna evening if the instructions given by him are not followed. However, the sauna evening will then be billed according to normal practice.
